

CNBC's Jay Leno's Garage Presidents Day Sweepstakes

Official Rules

February 20, 2017 — February 21, 2017

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Void where prohibited. The **CNBC's Jay Leno's Garage Presidents Day Sweepstakes** ("Sweepstakes") will begin on **February 20, 2017** at 12:00 P.M. ET and end on **February 21, 2017** at 8:00 A.M. ET ("Sweepstakes Period"). All times in the Sweepstakes refer to Eastern Time ("ET"). Odds of winning depend upon the number of eligible Entries (as defined below) received. Sweepstakes is subject to all applicable federal, state and local laws. **PRIZE (DEFINED BELOW) DOES NOT INCLUDE TRANSPORTATION, ACCOMODATIONS OR PARKING.**

ELIGIBILITY: Open only to permanent, legal United States residents who are physically residing in one (1) of the fifty (50) United States or the District of Columbia (excluding Puerto Rico, Guam, the Virgin Islands and other United States territories), and who are eighteen (18) years of age or older as of the start of the Sweepstakes Period. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. Sweepstakes Entities, as referenced herein, shall include CNBC, 900 Sylvan Avenue, Englewood Cliffs, NJ 07632 and NBCUniversal Media, LLC, 30 Rockefeller Plaza, New York, NY 10112 (collectively, "Sponsors"), and their respective parent, subsidiary, and affiliate companies, and their administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, promotion, or implementation of the Sweepstakes.

HOW TO ENTER: The Sweepstakes will consist of six (6) individual entry periods (each an "Entry Period"). Each Entry Period will (i) begin at a specified time (each an "Entry Period Start Time") as detailed in the chart below and will end at a specified time (each an "Entry Period End Time") as detailed in the chart below, and (ii) one (1) random drawing ("Drawing") will be conducted on or about February 21, 2017, for each Entry Period from among all eligible Entries (defined below) received during such Entry Period as specified in the chart below. Entries must be received before the end of the Entry Period to be eligible for the corresponding Drawing. There will be five (5) Winners (defined below) selected from each Drawing for a total of thirty (30) Winners selected throughout the Sweepstakes Period.

To enter the Sweepstakes, during the Sweepstakes Period, watch CNBC (check your local listings) during the second quarter of each hour beginning at 12:00 P.M. ET on February 20, 2017 and ending at 6:00 P.M. ET on February 20, 2017 to obtain the code word (“Code Word”). Then, visit the CNBC website at <http://jaylenosgarage.cnbc.com> (“Website”) and follow the provided instructions to complete and thereafter submit the entry form, which includes your name, email address, and the Code Word (“Entry”). All Entries become the property of Sponsors and will not be acknowledged.

You may enter once per Entry Period for a total of six (6) Entries during the entire Sweepstakes Period. Multiple Entries received from any person beyond this limit will void all such additional Entries. Entries generated by a script, macro, or other automated means or by any means that subverts the entry process will be disqualified. **Entries must be received before February 21, 2017 at 8:00 A.M. ET to be eligible for the Sweepstakes.** Sponsors’ computer shall be the official timekeeper for all matters related to this Sweepstakes. WINNER SELECTION AND NOTIFICATION: On or about February 21, 2017, thirty (30) potential Winners (“Winners,” each a “Winner”) will be selected in a random drawing by representatives of Sponsors from all eligible Entries received during the Sweepstakes Period. Sponsors will make two (2) attempts to notify potential Winners at the email address submitted at the time of entry. Each Prize will consist of the following: one (1) Jay Leno's Garage Vehicle Care Kit, and one (1) Jay Leno's Garage denim shirt, autographed by Jay Leno. Prize will be awarded "as is" with no warranty or guarantee, either express or implied by Sponsors. **PRIZE DOES NOT INCLUDE TRANSPORTATION, ACCOMODATIONS OR PARKING.**

Estimated Retail Value ("ERV") of each Prize is one hundred ten dollars (\$110). ERV of all Prizes is three thousand three hundred dollars (\$3,300). Actual Retail Value ("ARV") of Prize may vary. Any difference between ERV and ARV will not be awarded.

All details of Prize will be determined by Sponsors in their sole discretion. Sponsors reserve the right to substitute a similar Prize (or Prize element) of comparable or greater value. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner. Released Parties are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. Notice of such cancellation, modification, or suspension will be posted on the Website. Sponsors may prohibit any entrant or potential entrant from participating in the Sweepstakes, if such entrant or potential entrant shows a disregard for these Official Rules; acts with an intent to annoy, abuse, threaten, or harass any other entrant, Sponsors, or Sponsors’ agents or representatives; or behaves in any other disruptive manner (as determined by Sponsors in their sole discretion). Sponsors reserve the right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.

DISPUTES: THE SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY,

CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
