Following a careful review of the requested documents, this agency has determined that portions of the responsive documents are privileged from disclosure pursuant to FOIA Exemption 5 U.S.C. § 552(b)(6) which exempts disclosure of information that would constitute a clearly unwarranted invasion of personal privacy.

Fees associated with processing your request are minimal and waived.

Because your request has been partially denied, this determination may be appealed to the Assistant to the General Counsel (FOIA) at:

2. BACKGROUND: MARINE UNDERGOING URBAN SNIPER COURSE TRAINING WAS CONDUCTING NIGHT LIVE FIRE WITH M40A3. RIFLE HAD BEEN CLEANED EVENING PRIOR, AND PAGE 06 RUEOMFA3288 UNCLAS DURING DAY BEFORE THE NIGHT LIVE FIRE. MARINE CHAMBERED A ROUND AND PULLED TRIGGER.

THE WEAPON FAILED

- TO FIRE. MARINE BEGAN TO EXTRACT ROUND FROM WEAPON. THE WEAPON FIRED WHILE THE MARINE WAS RAISING THE BOLT HANDLE. FIRING OCCURRED WHEN HANDLE WAS APPROXIMATELY ONE QUARTER OF THE WAY UPWARD. THIS INCIDENT OCCURRED TWICE WITH THE SAME WEAPON.
- 3. THE CAUSE OF THE WEAPON MALFUNCTION IS UNKNOWN, BUT MAY HAVE INVOLVED THE M700 TRIGGER GROUP. AFTER INSPECTION AND CLEANING, THE REPAIRING ORGANIZATION WAS NOT ABLE TO DUPLICATE THE MALFUNCTION. THE FOLLOWING INFORMATION WAS RECEIVED FROM REMINGTON ARMS COMPANY. EACH TRIGGER ASSEMBLY HAS THE ADJUSTMENT SCREWS FACTORY SEALED WHEN IT LEAVES THE FACTORY, EITHER ON A RIFLE OR WHEN IT IS SOLD AS A PART.EMINGTON HAS NEVER RECOMMENDED THAT THE TRIGGER BE ADJUSTED BELOW OUR FACTORY PAGE 07 RUEOMFA3288 UNCLAS MINIMUM OF
- 3.5 4 LBS. IF THIS ADJUSTMENT IS MADE OR IF THE SEAR ENGAGEMENT SCREW IS ADJUSTED, A POTENTIALLY UNSAFE CONDITION MAY OCCUR."

THE FOLLOWING PROCEDURES WILL BE FOLLOWED IN ORDER TO ASCERTAIN IF A NEWLY INSTALLED M24 TRIGGER IS SERVICEABLE. TRIGGER WEIGHT WILL BE TESTED USING TRIGGER PULL WEIGHTS IN ARMORERS TOOL KIT AND BE SET TO BETWEEN 3-5LBS USING THE FINE TUNE ADJUSTMENT SCREW. THIS PROCEDURE WILL BE PERFORMED WITH A DUMMY CARTRIDGE IN THE CHAMBER. ONCE TRIGGER IS INSTALLED AND TRIGGER PULL WEIGHT IS SET THE BOLT WILL BE CYCLED (RAPID BOLT MANIPULATION) IN AN ATTEMPT TO GET THE WEAPON TO SLAM FIRE. ADDITIONALLY THE WEAPONS SAFETY WILL BE CYCLED FROM SAFE TO FIRE AND BACK IN AN ATTEMPT TO MAKE THE WEAPON SLAM FIRE. ATTEMPTS TO GET THE WEAPON TO SLAM FIRE WILL BE PERFORMED WITH AN EMPTY CHAMBER WITH NO CARTRIDGE OF ANY KIND IN THE CHAMBER. IF THE WEAPON DOES NOT SLAM FIRE AFTER THE ABOVE PROCEDURES HAVE BEEN PERFORMED IT IS SAFE FOR USE. IF THE WEAPON DOES FIRE AFTER THE ABOVE PROCEDURE IS PERFORMED THE TRIGGER WILL BE REPLACED AND THE PROCEDURE REPEATED. IF A WEAPON HAS A SLAM FIRE WHICH CANNOT BE RECTIFIED BY REPLACING THE M24 TRIGGER THE WEAPON WILL BE TAGGED AND EVACUATED TO PWS, WTBN, QUANTICO, VA TO DETERMINE THE CAUSE.
