

Watch For The Shark Sweepstakes
Official Rules
July 17, 2018—August 16, 2018

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Watch For The Shark Sweepstakes (“Sweepstakes”) will begin on July 17, 2018 at 8:00 P.M ET and end on August 16, 2018 at 2:00 A.M. E.T. (“Sweepstakes Period”). All times in the Sweepstakes refer to Eastern Time (“ET”). Odds of winning depend upon the number of eligible Entries (as defined below) received. Sweepstakes is subject to all applicable federal, state and local laws.

ELIGIBILITY: Open only to permanent, legal U.S. residents who are physically residing in one (1) of the forty-eight (48) continental United States or the District of Columbia (excluding Alaska, Hawaii, Puerto Rico, Guam, the Virgin Islands and other United States territories), and who are eighteen (18) years of age or older as of the start of the Sweepstakes Period. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. Sweepstakes Entities, as referenced herein, shall include CNBC, 900 Sylvan Avenue Englewood Cliffs, NJ 07632, NBCUniversal Media, LLC, 30 Rockefeller Plaza, New York, NY 10112 (collectively, “Sponsors”), and their respective parent, subsidiary, and affiliate companies, and their administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, promotion, or implementation of the Sweepstakes.

Each Weekly Drawing will consist of (i) two (2) entry periods (each an “Entry Period”) that will begin at a specified time (each an “Entry Period Start Date and Time”) and will end at a specified time (each an “Entry Period End Date and Time”) as detailed in the chart below, and (ii) one (1) random drawing (“Drawing”) will be conducted weekly on a specified date (each a “Weekly Drawing Date”) for the corresponding Entry Periods from among all eligible Entries (defined below) received during such corresponding Entry Periods as specified in the chart below. Entries must be received before the end of the corresponding Entry Periods to be eligible for the corresponding Drawing. There will be ten (10) Winners selected from each Drawing for a total of fifty (50) Winners (defined below) selected throughout the Sweepstakes Period.

To enter the Sweepstakes during the Sweepstakes Period, tune in to Shark Tank on CNBC on the dates and times listed above (“Participating Episodes”) (check your local listings).

A special code word (the “Code Word”) will appear on a shark graphic within the first ten (10) to fifteen (15) minutes of each of the Participating Episodes.

Then, visit the CNBC Primetime website at <http://cnbc.com/sharktanksweeps> (“Website”) and follow the provided instructions to complete and thereafter submit the entry form, which includes your name, telephone number, email address, and the Code Word (“Entry”). All Entries become the property of Sponsors and will not be acknowledged or returned.

You may enter four (4) times per Weekly Entry Period for a total of twenty (20) Entries during the entire Sweepstakes Period. Multiple Entries received from any person beyond this limit will void all such additional Entries. Entries generated by a script, macro, or other automated means or by any means that subverts the entry process will be disqualified. Entries must be received before August 16, 2018 at 2:00 A.M. ET to be eligible for the Sweepstakes. Sponsors’ computer shall be the official timekeeper for all matters related to this Sweepstakes. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. WINNER SELECTION AND NOTIFICATION: On or about each Weekly Drawing Date, ten (10) potential winners ("Winners", each a "Winner") will be selected in a random drawing by representatives of Sponsors from all eligible Entries received during the Sweepstakes Period. Sponsors will make two (2) attempts to notify potential Winners at the phone number and/or email address submitted at the time of entry. Each Prize will consist of one (1) Shark Tank prize pack containing one (1) Shark Tank T-shirt, one (1) Original Monkey Mat 5' x 5' mat, one (1) Scrub Daddy Flex Texture scrubber, one (1) ShowNo Poncho Style Towel, one (1) Rareform Light Duffle (1) Popcorn 28g mini Popcorn, one (1) Freaker one-size-fits-all beverage insulater. Prize will be awarded "as is" with no warranty or guarantee, either express or implied by Sponsors."

Estimated Retail Value ("ERV") of each Prize is one hundred dollars (\$100). ERV of all Prizes is five thousand dollars (\$5,000). Actual Retail Value ("ARV") of Prize may vary. Any difference between ERV and ARV will not be awarded.

Released Parties are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. Sponsors reserve the right to cancel, modify, or suspend the Sweepstakes or any element thereof (including, without limitation, these Official Rules) without notice in any manner and for any reason (including, without limitation, in the event of any unanticipated occurrence that is not fully addressed in these Official Rules). Notice of such cancellation, modification, or suspension will be posted on the Website. Sponsors may prohibit any entrant or potential entrant from participating in the Sweepstakes, if such entrant or potential entrant shows a disregard for these Official Rules; acts with an intent to annoy, abuse, threaten, or harass any other entrant, Sponsors, or Sponsors’ agents or representatives; or behaves in any other disruptive manner (as determined by Sponsors in their sole discretion). Sponsors reserve the

right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.

DISPUTES: THE SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY’S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
